Security & Regulation on The Good Exchange

- Donations are processed directly on Barclaycard secure portal and not on The Good Exchange platform
- No financial information (Debit/Credit cards) is stored by The Good Exchange
- The Good Exchange is regulated by Financial Conduct Authority (FCA) and the Fundraising Regulator (FR)

Cloudflare – (SSL data encryption, Firewall, DDos, BRM)




Best practice on The Good Exchange

- All users should have their own personal account no shared logins
- Set a secure password with at least one number, one capital letter and a character e.g.& ^ % \$!
- Avoid using generic email addresses e.g. info@, accounts@, admin@
- Log out after every session & clear cookies regularly
- Organisation Accounts should have one superuser who can add and manage users plus at least one other administrator
- To aid administration of financial matters e.g. invoicing, Direct Debit & Gift Aid a '**Finance contact**' should be added. (Activity reports etc)
- Keep your organisation information up to date: accounts/balance sheets, financial information, change of users etc.
