

Guidelines for acknowledging your grant

Congratulations on securing a grant from Greenham Trust. We want you to publicise your fundraising appeal and celebrate our support of your project. This can engage your existing supporters and bring new supporters on board with you, help tell the story of what you are aiming to achieve and bring awareness. Below are some guidelines for how you should acknowledge our funding in your internal and external communications such as newsletters, online, in publications, in press and social media.

First, to see how Greenham Trust, Greenham Business Park and The Good Exchange work together and how to position them in your messaging, please see the appendix below. In summary:

- **Greenham Trust** = the funder of your grant
- Greenham Business Park = the source of funds for Greenham Trust
- The Good Exchange = the online fundraising and crowdfunding platform owned by Greenham Trust

If your organisation maintains social media, please use it to engage your supporters with news of your fundraising appeal and our grant - to announce an amount awarded, to highlight project information, to update your followers about progress and also to share photos and stories when your project ends or reaches a special milestone.

Self-sufficient model

Greenham Trust makes money from letting property to organisations in the local area, and gives its surplus income back to the local community via charity grants. Greenham Trust is one of only two trusts in the UK that generate the majority of their income from investments in commercial property. It has created a truly self-sufficient, circular, business model, putting the revenue from a commercially managed property portfolio back into the community that lives and works in and around its business estates via its online crowdfunding platform, The Good Exchange.

Greenham Trust is a prime example of how organisations can use circular business models to create sustainable local and regional economies, showcasing how responsible property investment and management can be a force for good.

Purpose-built platform

The Good Exchange's cloud-based technology platform was built by a team of people employed by one of the UK's largest local funders (Greenham Trust), who understand the unique issues faced by funders and fundraisers.
